COOKIE SETTINGS:

- 1. Technical cookies: ACCEPT REJECT
- 1. They are necessary for the proper functioning of the website.



- 2. They allow data communication, session identification, access to restricted access parts, filling out and submitting a contact form, etc.
- 1. Personalisation cookies: ACCEPT REJECT
 - 1. Allows you to specify or customize some features of the general options. For example, define the language, regional configuration or the type of browser.
- 1. Analytical cookies: ACCEPT REJECT
 - 1. They allow us to better understand the preferences of users on our website and thus make improvements.
 - 2. We collect anonymous information about the use of our website.
- 2. Advertising cookies: ACCEPT REJECT
 - 1. They allow us to show you advertising that may be of interest to you.
 - 2. They display ads targeted at you anonymously.
- 3. Behavioural advertising cookies: ACCEPT REJECT *only for scenario 5
 - 1. They allow you to be shown personalised advertising to a profile based on your browsing habits, forming a profile of your preferences as a user.

SECOND LAYER:

WHAT IS A COOKIE?

This website uses cookies and/or similar technologies that store and retrieve information when you browse. In general, these technologies can serve a wide variety of purposes, such as recognizing you as a user, obtaining information about your browsing habits or personalizing the way in which content is displayed. Our specific uses of these technologies are described below.

WHO USES COOKIE INFORMATION?

WHAT TYPES OF COOKIES ARE THERE?

Cookies can be classified, by virtue of their own characteristics, into various categories.

- 1. Depending on the entity that manages it:
- First-party cookies: These are those that are sent to your computer and are managed exclusively by us for the best functioning of the Website.
- Third-party cookies: These are cookies that are sent to your computer and are not managed by us but by a third party.
- 2. Depending on the period of time they remain activated:
- Session cookies: These types of cookies collect and store data only while the User accesses the Website.
- Persistent cookies: Through this type of cookie, the data is still stored and can be accessed and processed for the period defined by the person responsible for the cookie, and can range from a few minutes to several years.
- 3. According to the purpose:
- Technical cookies: These are those that allow the user to browse through the website, platform or application
 and to use the different options or services that it offers, such as, for example, to control traffic and data
 communication, identify the session, access restricted access parts, remember the elements that make up an



order, carry out the process of purchasing an order, making the request for registration or participation in an event, using security elements while browsing, storing content for the dissemination of videos or sound or sharing content through social networks.

- Personalisation cookies: These are those that allow the user to access the service with some predefined general characteristics, such as the language, the regional configuration from which the service is accessed, etc.
- Analysis cookies: These are those that allow the person responsible for them to monitor and analyse the
 behaviour of users of the websites to which they are linked. The information collected through this type of
 cookie is used to measure the activity of websites, applications or platforms and to create browsing profiles
 of users of these sites, applications and platforms, in order to introduce improvements based on the analysis
 of the usage data made by users of the service.
- Advertising cookies: These are cookies that allow the management, in the most efficient way possible, of the
 advertising spaces that, where appropriate, have been included in the website, application or platform from
 which the requested service is provided, based on criteria such as the content edited or the frequency in
 which the advertisements are displayed.
- Behavioural advertising cookies: These are those that allow the management, in the most efficient way possible, of the advertising spaces that, where appropriate, the publisher has included on its website, application or platform from which it provides the requested service. These cookies store information on user behaviour obtained through the continuous observation of their browsing habits, which allows the development of a specific profile to display advertising based on it.

WHAT RIGHTS DO YOU HAVE OVER THE PERSONAL DATA PROVIDED?

As a user, you can exercise the following rights:

- Right of access: You have the right to obtain from the company confirmation as to whether o not personal data concerning you are being processed, and, where that is the case, access to the personal data.
- Right to rectification: You have the right to obtain from the company without undue delay the rectification
 of inaccurate personal data concerning you. In the rectification application you should specify the personal
 data you wish to rectify.
- Right to object: You have the right to object, on grounds relating to your particular situation, at any time to processing of personal data concerning you which is based on the legitimate interest. The company shall no longer process the personal data unless it demonstrates compelling legitimate grounds for the processing which override the interest, rights and freedoms of the data subject or for the or the establishment, exercise or defence of legal claims.
- Right to erasure: You have the right to obtain from the company the erasure of personal data concerning you.
- Right to data portability: You have the right to receive your personal data, which you have provided to the company, in a structured, commonly used and machine- readable format and have the right to transmit those data to another controller without hindrance from the controller to which the personal data have been provided.
- Right to restriction of processing: You have the right to obtain from the company restriction of processing where: the accuracy of the personal data is contested by the data subject; the processing is unlawful and the data subject opposes the erasure of the personal data and request the restriction of their use instead; the controller no longer needs the personal data for the purposes of the processing, but they are required by the data subject for the establishment, exercise or defense of legal claims.
